All while making sure the HomeTouch mailing, prayer list, incoming mail, supply orders, Presby Post, Sunday announcements, cemetery records and sales, etc. are all still taken care of and kept up to date each week. (No worries, I've placed the order already for this year's palms.) I miss Pastor Drew. It is stressful and can wear me out, but at the same time I am being stretched (way) out of my comfort zone and remolded into the person that is needed during this Season. Please be patient.

This year's volunteers were amazing as always. Ken Marshall is always quick to help update our website (abseconpresby.org) with new information on a weekly basis no matter where in the world he may be. Ann Wallace continues to come in to count your offerings, make the weekly deposit to the church account, and fill in for me during my time off. Thanks also to Franklin and Don for spending hours setting up the new security equipment and readying phone lines for the switch from Verizon to Comcast phones. Special thanks to Patricia Allen for graphics assistance as well as proofreading documents. Virtual hugs all 'round!

Christian Education

It was a quiet but encouraging year for the Christian Education Committee. Since March 2020 all in person programs had been suspended but luckily technology was on our side.

Pastor Drew, Betsy Eberhard and I were able to put together a zoom Sunday school that allowed us to meet with children every Sunday. It was a great way to connect with families to continue sharing God's word. We continued this all through October 2021 when, Praise the Lord, we were able to meet again, in person. The fall of 2021 we received the green light to come together for Sunday school. We offered three classes, a pre-school to 1st grade class, 3rd through 6th grade class and a teen Bible study led by some of our amazing young men. We hosted an indoor movie night and a Birthday Party for Jesus! All these events were planned with Covid protocols in mind but what a blessing to be together again!

We thank all those who helped in anyway with our programs and pray that we will be able to continue to share the love and the Word of the Lord for 2022.

As we move forward, Mission and Evangelism realizes that needs in our community will always be there. We pray, with God's guidance, that we will continue to be ready and able to help the best we can.

Worship Committee

Honor and Glory to our Lord!

These words, I hope and believe, will be instrumental in our church and in our Worship Committee's thoughts and actions as we move forward in the coming year.

Despite still operating under Guidelines related to Covid 19, we have progressed in this unusual year.

During the Easter season we placed flowers on our altar, in honor and/or memory of our loved ones, and we thank Laura Pugliese for making the trip to pick up these flowers. The flowers not picked up after Easter Sunday by those who ordered them were delivered to various members and shutins. Mission bouquets were also donated. Artificial arrangements were provided by Donna Hughes which were placed on our shelves.

After being closed for over a year, we re-opened for worship slowly, following State and Presbytery Guidelines, first with pre-registration, alternating pews, social distancing, assigned seats and masks, with Franklin Nale in his "bubble." Incidentally, Franklin was approved and hired by Session as Worship Technology Specialist, a wonderful decision.

We then progressed to opening fully, still following State and Presbytery Guidelines, with alternating pews, social distancing, and masks while singing in our seats.

During our closure, our more than competent Administrative Assistant, Gay Channell, developed a new Bulletin and later invented "Bits and Pieces" containing additional information for congregants. Louise Speitel, Ken Marshall, Franklin Nale, and Judy Stebbins have been acting as Online Liturgists posting our readings hymns, etc. each Sunday, with Ann Wallace as back-up. Naida Burgess offered to deliver hymnals on loan to anyone requesting them in order for them to follow our services in an easier way.

Mary Bew has been lining up ushers with Naida Burgess providing Lay Assistants. Ann Wallace has been supplying acolytes when possible, enlisting help from Lay Assistants or Ushers to perform this duty or acting herself when necessary. Lynn Adkisson and Ann Wallace have been posting our hymn numbers each week in the front of the church. Ann has also been providing our in-person congregant count, with Franklin providing our online watcher count.

We have brought back our ability to order altar flowers in memory/honor of someone with a signup calendar next to the Sanctuary door. There is also a Prayer Request book on the table for making your personal requests. This book will be passed on to our Pastor who is preaching that day.

On Pentecost Sunday, May 23, Nicholas Sabo and Kwame Gyasi, were confirmed during our service. On a later date, Franklin Nale joined as a member.

In June we faced more challenges when our Pastor, Drew Mangione, moved on to accept a new position due to personal reasons and a Congregational Meeting was held on June 27 for this purpose. After meeting with Presbytery, we learned there were no Interim Pastors available. After contacting various Pastors on Presbytery's Pulpit Supply list, we have been fortunate to fill our Pulpit each week with a number of visiting Pastors who have provided us with wonderful sermons. We will continue along these lines with other plans in the works. Ruling Elder David Watts offered to provide us with a Christmas Eve service, which was approved by Session.

Our fantastic and extremely talented Music Director Rick DeKarski has again begun to play the organ as well as the piano. If interested in singing during the service so that online watchers can hear the hymns sung, Franklin has offered to provide microphones and Rick has agreed to meet with anyone so inclined at 10:15 for a short rehearsal.

In closing, I truly appreciate and thank all the Worship Committee members: David Burgess, Naida Burgess, Mary Bew, Betsy Eberhard, Louise Speitel, Bill Keener, Franklin Nale, Rick DeKarski, Georgina Umoren, Ginny Davenport and last but certainly not least, Ann Wallace. I must also include Gay Channell, for her invaluable assistance.

As we move forward into another year, may we keep in mind our love for our glorious Lord!

The garden still produced food for the hungry. We are thankful for these people who have kept going through all the changes. As we move into 2022, we will ask each of you to consider what talents you have to share to help us open and bloom again.

This year, 2021, was a year of highs and lows for our congregation. On the one hand, we were finally able to reopen the sanctuary for worship, albeit with some restrictions. The vaccines have allowed us to take a breath of relief from the pandemic, but at the same time, the virus continues to challenge us. We had more church members, family members and friends afflicted with Covid-19 this year than in 2020. Sadly, we also know of a few that we lost to the disease. This has forced us to remain vigilant and thus, some of the restrictions have to remain in place.

Sadly, Pastor Drew left in June to accept a new calling which left us without the guidance of a pastor once again. We have a Mission Study Team up and running and once they complete their tasks; we should have a Pastor Nominating Committee put together soon to begin the vetting process. With the help of new technology, such as Zoom, Skype and Teams, we are hoping much of the process can be done remotely.

We have upgraded some of our equipment, with the help of a Presbytery technology grant, which allows us an improved presence on Facebook Live, for those who wish to continue to view worship from home. Thank you to our new Worship Technology Specialist, Franklin Nale for being instrumental in this upgrade. We have also converted the phone system from Verizon to Comcast which will hopefully save us a lot of money. We upgraded our building surveillance system to high-definition color cameras with options to add even more cameras which will help Gay, and the church staff feel safer, especially since they are now often alone in the building. Thank you to Gay for always fielding my questions and for all you have done to keep the ship afloat. We unfortunately had several heating/air conditioning failures in the Sanctuary, Madden Hall and the Stopfer building this year, one of which required the complete replacement of a 30-year-old system in Madden Hall. We are in the process of upgrading our long obsolete payroll time clock. We still need to make repairs to the Teen Lounge and kitchen ceilings and upgrade the exterior front doors. Thank you to Dan Hughes, who will be stepping down as Property Chairman, for your dedication all these years.

Our church finances continue to be solid, thanks to the pledges and generous giving of our congregation. The Stock Market has also seen highs and lows this year but has helped us to meet our budget which has seen some cost increases. Our rental properties are fully occupied but have incurred some major expenses this year, such as a water main break at 23 School St and several plumbing and HVAC issues at the Stopfer building. A generous donation from the Hamer family several years ago has helped us over several financial obstacles. Thank you to Bob Hudak and the Finance Committee for guiding us through these uncertain times.

Our Cemetery Committee was saddened with the loss of long-time member/treasurer Jerry Hoenes. He will be missed. On the other hand, we added Tina Brown and Bud Burgess to our Cemetery Staff this year, and they have been doing a wonderful job keeping the cemetery, as well as Manse and Church properties, neat and trimmed. Thanks go to Melvin Washington and his committee for being able to complete some long-standing tasks this year as well as working hard to keep the cemetery maintained.

Our Personnel Committee was busy reviewing and updating employee contracts, upgrading existing job descriptions as well as adding the new position and job description of Worship Technology Specialist. Thank you, Cindy Gorgo, for your time and commitment.

Thank you also to Betty Lloyd who has continued to be an invaluable at-large member of our trustee board as well as the Finance Committee.

As we continue to navigate through rough waters, I wish to thank our church family for continuing to come out and give their gifts of time as well as tithes and offering. God truly has a plan for us and as we remain faithful.

Finance Committee

My thanks to the members of this group for another year of dedication: Betty Lloyd, Ann Wallace, Don Wong, Donna Hughes, Loretta Metz, and Anne Hyatt. Unfortunately, we lost Jerry Hoenes this past year, whose diligence and presence will be missed by all.

We had a client review of our UBS account with Jeanne Eisley at our May 18th committee meeting. The church funds are continuing to do well in a moderately conservative account, professionally managed, with a mix of stocks and income funds. The McMullin fund paid out a dividend of over \$24,633 to our general fund this year which helps pay for all of our church expenses.

We had two withdrawals from our B. F. Edwards account this year. In May, we withdrew \$7,500 for audio/visual technology upgrades so the church could better serve everyone in our church sanctuary or viewing the service from home. In July, we withdrew another \$8,730 for air conditioning repairs to our church. This account continues to do very well along with the stock market, but it was decided in our September finance meeting to move this fund into a more defensive and slightly more conservative fund, based on the recommendation of the account manager at B. F. Edwards.

In August, our full loan of \$31,585, which was given to us for the Payroll Protection Program, was forgiven by the federal government. This was a long process that Anne Hyatt and Ann Wallace took on and, through their diligence and perseverance, were able to see it through to completion. My heartfelt thanks go to both of them for a job well done.

Our church giving continues to remain steady through this Covid pandemic period, and we are always thankful for that. Our online giving, which started in May 2020, continues to be a source of revenue that has made it more convenient for people to utilize.

Some of our regular groups: 3rd Step, AA, elections, God is Faithful, are starting to make plans to return in the near future as the pandemic will allow, or have already returned in a limited capacity.

Our tenants in 19 and 23 School Street continue to be good tenants. Both of these properties continue to generate positive income for the church, as well as Mrs. Barnes' Playhouse. All continue to be professionally managed by a local realtor, who oversees the day-to-day needs of each property. 23 School Street and Mrs. Barnes' Playhouse had some building issues with plumbing, roofs leaking and HVAC systems, but were repaired as needed. The Bakely House at 15 School Street continues to meet the needs of our community with a family currently occupying it.

If you have not turned in your pledge cards for 2022, please take the time to do so now. These pledges are our guidelines in preparing our budget and keeping expenses in line. Also, please be sure

to pay your share of the Per Capita Expense so the church does not have to take the money from the General Fund.

Church Facebook Site – Features Sunday Services Live

Ken Marshall set up this public Facebook page in Aug 2018. Prior to that our church only had a private Facebook group. This site is intentioned for community outreach. Little did we realize at the time the important role it would play broadcasting our church services at the onset of covid.

The church Facebook page includes live on-line church services as well as Facebook-archived videos of past services.

During the early days of covid, when worship was restricted to on-line only, Pastor Drew quickly adapted and broadcast the services on Facebook-live using his smart phone.

A couple of iterations later and voila, we now have a first-class audio/video system approved by our audio-video selection group and the Session. Franklin Nale, Don Wong and Rick DeKarski installed our current audio/video recording and networking capability for broadcasting church services. All aspects were expedited and facilitated by pastor Drew.

Franklin Nale is the main administrator for the Facebook site. Franklin was hired as our church worship technology specialist in 2021. Frank's duties include:

- He records all services on "Facebook Live". He simultaneously records the services on the church computer and posts the church Sunday bulletin and Sunday newsletter, "Bits and Pieces". Franklin schedules the bulletin and newsletter to be posted exactly 1 hour before the service starts.
- Starting in November 2021, all services were recorded on the church computer, so there is always a backup to the Facebook video archives.
- Franklin records and/or broadcasts wedding and funeral services on request.
- Franklin maintains our current audio/video recording and networking system for broadcasting church services
- Franklin and Don installed, and Franklin maintains our church video surveillance security system.
- Franklin has many mikes on hand so singers can share their voices with the Facebook viewers who otherwise only hear only the organ or piano.

Gay Channell posted the responses and the hymns as comments for the Facebook live service for the first half of 2021. Ken Marshall, Louise Speitel and Judy Stebbins jointly took over that job after Drew left in July 2021.

Last but not least we would like to thank Janet Gee for coordinating and expediting pulpit supply, and her working with session to expedite and troubleshoot problems encountered along the way.
